

# WMLOA Official's Agreement

By signing this form, you have indicated your desire to be considered for service to the WMLOA as an "Independent Contractor Boys Lacrosse Official" for the agreement period of the current lacrosse season beginning from the signature date and until July 15th of this current lacrosse season.

**In consideration of the following mutual promises, WMLOA and the official agrees as follows:**

- 1.) Official desires to be an "independent contractor" for WMLOA and agrees to pay all association dues and/or any fines and penalties assessed during the current season.
- 2.) Official agrees to abide by the rules and requirements as prescribed in the By-laws and Constitution of the WMLOA.
- 3.) Official agrees that by accepting assignments from WMLOA he/she has an obligation to complete his/her assignments in a professional manner.
- 4.) Official agrees to refrain from participating in actions or any matter to be deemed not in the "Best Interest" of WMLOA or which may cause harm to the reputation of the official and/or this association.
- 5.) Official understands that no future obligation of acceptance to the WMLOA is guaranteed and eligibility is determined by the Executive Committee.

The WMLOA shall accept the official as an "**Independent Contractor**" for as long as the agreement period or said official is deemed to be considered in a good standing within the WMLOA as detailed in the by-laws and constitution of this association. This agreement may be terminated by the WMLOA Executive Committee at any point during the length of the agreement for violation(s) of the association's by-laws and constitution or actions to be deemed by the Executive Committee as not in the "Best Interest" of this association.

The WMLOA by accepting official's agreement is not required to and the official agrees; that WMLOA is not required to provide official with any specific number of assignments, nor provide official with specific game level assignments during the course of official's membership in this Association. Any assignment the official receives is subject to cancellation or change by WMLOA due to schedule corrections, inclement weather, injury or the discretion of WMLOA based on performance, ability or complaint or scheduling needs.

The official recognizing that officiating lacrosse games carry with it a certain assumption of risk of injury, hereby agrees that in the event of injury, accident or damage sustained by him/her as a result of any assignment and/or injury, accident or damage sustained by any party to such assignment, the official agrees to hold harmless WMLOA, to include, but not limited to any member of the Executive Committee, assignor, staff member of WMLOA and/or any institution served by WMLOA for any such injury, accident and damage sustained.

Failure of the official to abide by the rules and regulations as set forth in this agreement, the by-laws and constitution of this association and any state laws may result in termination from this association. The enforcement and interpretation of this Agreement shall be determined and governed on by the Executive Committee of this Association.
